LET'S CHAT: Reducing Crime in Our Neighborhood

On March 23rd, the RHOA sponsored an informative "**Let's Chat**" meeting at the home of Lisa and Mark Pope. The main presenter was Sergeant Paul Cervantes, L.A. County Sheriff's Department Lomita Station Detective Bureau Chief. Also contributing were Alexa Regaldo, Sheriff's Department Criminal Analyst, and Jessica Slawson, Management Analyst from the City of Rolling Hills Estates. Jay Fodor, an RHOA Neighborhood Watch Block Captain, also contributed.



Sergeant Cervantes identified residential burglaries and catalytic converter thefts as the major residential crime problems for the Lomita Sheriff's Station. The burglars frequently enter through rear slider doors and collect wallets, laptop computers, jewelry, and smartphones. They are in and out of the victim's house in three minutes. Theft of

catalytic converters also occurs in minutes by experienced thieves without the owners' knowledge.

The sergeant said that houses backed up to horse trails, unimproved property, or parks are frequent targets of burglars. In addition, vacant, sometimes unlocked, or poorly lit houses facilitate many of these crimes. Keeping a car in the driveway, a light on a timer in the front of the house, and removing accumulated newspapers and mail helps discourage break-ins. Having your neighbor's phone number available in case of a nearby incident is also a good idea.

A residential audible alarm system is another good security measure. The system will alert the alarm company to call the homeowner if the alarm is triggered and send the call to the Sheriff's department if the homeowner does not respond. A home surveillance video system is also a good way to discourage burglars and provide perpetrator descriptions and license plate numbers if needed.

Community reporting has a role in reducing these crimes. Residents can serve as an additional set of eyes for the Sheriff; **if you see something, say something.** It is okay to report suspicious activity in the neighborhood. **The Sheriff's non-emergency phone number at the Lomita Station is (310) 539-1661**. Cities on the PV Peninsula have "Flock video camera systems" installed at major road intersections to monitor vehicle traffic. Information from these systems aids the Sheriff's detectives in tracing the burglar's vehicles.

For homeowners, other suggested protective measures include improved door locks, applying a specialized clear film over windows and sliding doors to make them harder to shatter (burglars mostly smash the windows), a well-secured home safe, a doorbell camera, and a home security system with video coverage on all sides of the house.

To help reduce the number of catalytic converter thefts, the Lomita Sheriff's Station is working with Palos Verdes cities to develop a catalytic converter "etch and sketch" event. Your RHOA will send details through our website when the event details are finalized

Jay Fodor, a Neighborhood Watch Block Captain for Rollingwood, commented on an NW experience in December in which a neighbor's security camera captured a theft from a residential mailbox. The video was provided to the Sheriff's detectives to aid in their search for the mail thieves. This example confirms the importance of Neighborhood Watch in contributing to the safety of our community.

RHE City News and Information:

Nearing Completion of New Play Equipment at Rockbluff Park: Installation of protective handrails along the walkway in the equipment play area should be completed very soon. Weather and contractor issues have pushed the inauguration date back several times. Although the play equipment is in place, residents should continue to respect any "caution" tape in the vicinity of the play equipment walkway.

An Unofficial Report on California's recent "atmospheric river" events: Rollingwood's unofficial meteorologist reports that his home rain gauge has registered 27.98 inches since October 1, a

dramatic increase above the normal annual average of 15 inches per year in Palos Verdes.

The City of RHE: There is a seat available on the Park & Activities Commission for the term expiring December 31, 2024. The City is accepting applications through Friday, April 14, 2023, at 4:30 p.m. at City Hall. Candidates for commissioner will be interviewed by the City Council in April. Commissioners must be residents of the City of Rolling Hills Estates and registered voters. Park & Activities Commission information is available on the RHE City website at: RHE.city/PACommission.

In addition, a student art contest for grades K-8 and free paper shredding services will be available in the parking lot near El Pollo Inka Restaurant.

Palos Verdes Peninsula Annual Brush Clearance Notice: L.A. County Fire Department inspections of properties in designated high fire hazard zones begin June 1. Residents in these zones are required to maintain defensible space on their property and near structures. Information on the requirements, inspection fees, landscaping recommendations, and Frequently Asked Questions are available on the City's website at RHE.City/BrushClearance.

Crime Report from L.A. County Sheriff's Department: No crimes were reported in Rollingwood between March 1 and March 25, 2023. In February, one catalytic converter was stolen from a vehicle on Silver Spring Dr., and there was an attempted catalytic converter theft on Kingpine Rd. Community Liaison Deputy: Deputy Ben Russell is the current liaison deputy for Rollingwood and Rolling Hills Estates. Two examples: The City contracts with the Sheriff's Department to help families plan and prepare to survive disasters in the City. The City also developed and maintains a Joint Hazard Mitigation Plan with the City of Rancho Palos Verdes and emergency planning consultants.

Warren Arata, Community Appearance Updates

Spring!

It appears that we have passed our official rainy season, which was historic. We have a record snowpack in the Sierras, and authorities are just starting to realize the upcoming problem with the thaw and subsequent flooding.

In Rollingwood, we are experiencing an explosion of growth of plant material – and a lot of it is not what we want. Weeds abound. Every week that passes makes them more difficult to remove, and the soil becomes less pliable. If you haven't started to clear the weeds, now is the time! Everyone should have received a notice from the County regarding weed abatement in February. We reside in an area considered a high fire hazard risk and must conform to the standards that the County has recently updated to aid in preventing structure fires. The LA County Fire Department will begin inspections on June 1. They will work with residents who are addressing their brush clearance requirements to avoid punitive measures.



Of particular note is Zone 0, an ember-resistant zone within 0 to 5 feet of a home. It is a new part of the clearance mandates under California Assembly Bill 3074. Refer to the above link for the description of this new requirement. AB 3074 won't be enforced until 2024. This year, though, we still need to look to conform to 2023 requirements. June 1 is approaching, so now is the time to address possible issues.

Rolling Hills Estates has been working with the Fire Department because of these new updated requirements and confused messaging in some instances. In coordination with the other Cities, Rolling Hills Estates has created resources to help navigate the concerns and questions of residents. If you navigate the Rolling Hills Estates website, you can find most of the information you need regarding the current and future requirements. 
