#### Neighborhood Compatibility

The City has implemented neighborhood compatibility studies to describe clearly the established pattern of development in each neighborhood. The studies ensure that new construction and modifications to existing homes respect the established pattern within various neighborhoods. Rolling Hills Estates Municipal Code, section 17.62 et. seq, Neighborhood Compatibility, lays out the relevant code sections to maintain the integral elements of the City's rural character. There also is a review process for new construction and modifications to existing structures in neighborhoods in the City.

#### **Rockbluff Park Playground Equipment**

Rockbluff Park is one and a half acres of beautiful parkland located at the end of Rockbluff Drive.



In Spring, the City sent out a survey to the neighborhood seeking input on the future playground equipment to be replaced at Rockbluff Park. With nearly 70 responses, the input received helped fine-tune features proposed. The play equipment is expected to serve ages 5-12 with a slide, climbing feature, shade and other creative play features. In addition, the City is also proposing a new swing set that will offer a regular swing in addition to toddler and accessible swings. The subcommittee continues to work with City staff and Parks and Activities Commissioners on finalizing the proposals which will be reviewed by the Commission at its next regular meeting of October 20, followed by City Council's review and ultimate approval.

#### Vice President Doug Wickstrom's News from Community Relations and Ordinance Education RHE City News

#### Management Residential Organics Program.

Organic waste disposed of in landfills emits 20% of the state's methane, a "short-lived" climate pollutant 84 times more potent than carbon dioxide.

To respond to the climate crisis, California is implementing statewide organic waste recycling and surplus food recovery through SB 1383, signed into law in September 2016 by Governor Edmund Brown Jr.



In case you missed it, Waste Management announced the change to its organic waste collection service in July 2021. You can now place food scraps (Produce, Meat, Dairy, Bakery, and Food-Soiled Paper) in your "WM Green Organics Cart" along with the usual grass clippings and yard trimmings.

WM recommends collecting the food scraps (listed above), wrapping them in newspaper or PAPER bags, and placing them in the green-colored collection cart. Plastic, glass, metal, and waxed paper are NOT acceptable for the green cart. The organic waste-filled paper bags should now be included with other green yard waste and not placed in the gray, general waste container. #### Residential and Commercial Projects on Hawthorne Boulevard at Via Valmonte

As mentioned in previous newsletters, the RHOA monitors the activity on the following projects due to their potential impact on traffic flow along Hawthorne Blvd. at the intersection with Via Valmonte:

#### • 24601 Hawthorne Boulevard Mixed-Use Residential and Commercial Project

An 11-unit residential project (plus 3,000 sq. ft. of commercial space) is approaching the "Public Hearing" stage per City of Torrance Planning Department procedures. The department released an "environmental assessment" for public review on June 6 and received many written comments. Of those comments, the majority were in opposition to the project. The City of Torrance Planning Commission will consider the project for approval at a public hearing within the next few weeks. #### • Butcher/Solana Project

The proposed 248-unit Butcher/Solana Real Estate Development in the City of Torrance (also near the intersection of Via Valmonte and Hawthorne Blvd.) remains in "limbo" according to the City of Torrance Planning Department. Torrance has suspended its planning review of this large residential project pending further steps by the developer.


# Covid-19 statistics for LA County and the City of RHE:

#### **Beautification award:**

#### **Kingspine Road Entry**

The HOA has submitted the plans to the Parks and Activities Commission for review. We hope to know by the publication date of this newsletter if they are approved and if we have received a matching grant to clean up the parkways and install the proposed landscape.

#### Preventative Measures for a Safer Environment

We are well into fire season, and properties with dense tree canopies and shrubs, especially if they are dead or dry, are potential fire hazards. Please refer to the following link regarding brush clearance. https://fire.lacounty.gov/fire-hazard-reductionprograms/. This year, we have watched communities in the northern part of the state experience devastating fires resulting from a dangerous combination of massive amounts of built-up fuel and high winds. Low humidity and winds aided in carrying firebrands far from the leading edge of the active fire.

Summer ended on September 22 with the arrival of the autumn Equinox and our cooler Fall weather. We all should be looking at clearing out dead and dying plant material, pruning, and removing excess growth.

Most of Rollingwood comprises older single-family ranch-style homes indicative of post-war construction. Extended low-pitched roofs and exposed rafter tails are features that catch these firebrands. Any damaged roof vents will allow firebrands to enter the attic space and start a fire from within. Rollingwood is set on a sloped site, and houses are tightly spaced, which means a bit of participation is required from all to ensure that our entire neighborhood stays safe.

Several websites outline preventative measures and typical problems that we all have to some degree and how we can all create a safer environment.
