## Trash

#### RHE Municipal Code section 8.20.080 – Use and Placement of Containers and Bulky Items

2. Time of Placement. No person may place a container adjacent to a street or public right-of-way before 4 PM on the day before the regularly scheduled collection day, nor may any person place any bulky items adjacent to a street or public right-of-way before 4 PM on the day before the collection day set by the solid waste collector. All containers or bulky items must be placed in a proper collection location by 6:30 AM on the day of collection.

RHOA also requires that all trash containers be stored in a location that is not within public view.





The tranquil summer in Rollingwood was disturbed on August 8th by two residential burglaries. One was via a forced entry of a rear window and the other was via an open rear window. The Lomita Sheriff's Station Detective Bureau reports that both cases are still under active investigation.

The detective said that investigators will check for video surveillance cameras in the area of a break-in. Please keep that in mind when reporting a burglary or other crime.

#### **Dead Brush along Silver Spur:**

Rolling Hills Estates recently has been working on removing the dead brush along the pedestrian path on the east side of Silver Spur. Up until now, the dead shrubs were becoming a bit of an eyesore, not to mention a fire hazard.

#### **Beautification award:**

The beautification award this Summer went to the McCown/Ross Family at 6 Silver Spring. They renovated their front yard, removing their lawn and replacing it with a great looking landscape requiring less water and maintenance. It looks beautiful! Thanks to the McCown & Ross's for helping make our neighborhood look so inviting. In recognition of their efforts, the Rollingwood HOA Board has awarded them a \$25.00 gift card. As we roll into Fall and cooler weather, we enter a period of the year best suited to installation of new landscapes. The weather is cooler and new plants take advantage of upcoming Fall and Winter precipitation.

#### Sidewalk repair, street tree maintenance:

The latest sidewalk repairs this year were done by LA County on Dunwood Road. Every year the City and County determine where they will work to address sidewalk and street tree issues. Your RHOA Board has been working with the City over the years to aid in the determination of the most challenging areas that required attention. This year the City also helped themselves with a heaved sidewalk at the bottom of Rockbluff Drive. Your RHOA Board with the resident that fronted the damaged sidewalk approached the City to repair the damage, and it was taken care of. If you have any dangerous sidewalk situations fronting your property, one that would be considered very hazardous, please don't hesitate to contact your RHOA board to report it. Same goes with any street trees that pose a hazard. If there are broken branches, dead trees, etc. in the City right of way, please report them to the City to assure they are aware of the situation. ## **Brush Clearance:**

The inspections that started in June by LA County Fire Dept should have been completed by now. Those who have properties that are in the High or Very High Fire Hazard Severity Zones, (as determined by CalFire) should have received notices by LACFD of compliance or orders for addressing a potential fire hazard.

Next year there potentially could be a more stringent brush clearance mandate that will make it more difficult to comply with the LACFD'S Defensible Space Program. State Assembly Bill 3074 (AB-3074) will require an extra layer of defensible space adjacent to structures. See the links below for more information.
