Annual Meeting

The Rollingwood HOA Annual Meeting was held on October 8, 2024. Our guest speakers were Velveth Schmitz, Mayor of Rolling Hills Estates, and Frank Zerunyan, City Councilman, Rolling Hills Estates.



Mayor Velveth Schmitz was elected to the Rolling Hills Estates City Council in 2015. Velveth has been volunteering with the city of Rolling Hills Estates since 2006. She has served as a Commissioner on the Park and Activities and Planning Commissions.



City Council Member Frank Zerunyan is a three-term mayor and still serving Council Member in the City of Rolling Hills Estates. In his role as a public official, after serving as Chair of the Planning Commission in Rolling Hills Estates,

Frank was elected to the City Council in 2003 and reelected in 2007, 2011 and 2015.


Mayer Schmitz offered an overview of the challenges and progress made by the City on multiple issues. Topics included an improvement plan for traffic flow within the City using grant money; development of a pedestrian plan; completion of Founder's Park; launch of the George F. Canyon project; approval by the State of the "Housing Element" plan; and work on the Fire Warning and RHE Emergency Alert systems.

Councilman Zerunyan addressed Issues related to housing requirements placed on cities by the California state government. He mentioned that state affordable housing requirements are not necessarily bad since they encourage persons such as teachers, police officers, and nurses to become residents of the cities in which they are employed.

Presentations were followed by a question and answer session. Among the topics were: the State-mandated housing goal; concerns over traffic congestion and traffic planning; increasing use of and lack of traffic enforcement on electric bicycles ridden by children; role of the City, schools, law enforcement and parents to insure safe use of the electric bikes; school programs addressing safety when riding ebikes; lack of ability of the City to become involved in the "Ironwood/Silver Spur Condominiums" project; and, whether the City will implement plans to install a landslide monitor system.

Community Awareness Guide to E-Bikes

The L.A. County Sheriff's Department recently prepared a handy community awareness reference guide to electric bicycles. The guide is expected to be available online at https://lasd.org under the "publications section" in the next few weeks.

Here are a few of the highlights from the guide:

The California Vehicle Code [312.5 (a) CVC] defines an E-bike as a "... bicycle equipped with fully operable pedals and an electric motor of less than 750 watts."

- There are three classes of E-bikes (Classes 1, 2, and 3) depending on the degree of pedal assistance required to reach a speed of 20 miles per hour or 28 mph for a Class 3 E-bike.
- The Sheriff's guide cautions that: "Parents are legally and financially responsible for the actions of their children." Also, "E-Bike speeds may be too much for children to control. Know your child's riding abilities."

- The guide also presents checklists for 'Theft Prevention/Recovery,' and steps to take before purchasing an E-Bike.
- A closing note on the E-Bike guide points out that several types of two wheeled vehicles that may look like E-Bikes are actually electric motorcycles which require a motorcycle license to drive.

Silver Spur Canyon 482 Unit Condominium Project Update

The proposed large condominium project, located west of Silver Spur Road in the City of Rancho Palos Verdes, was one of the topics discussed at the RPV Planning Commission meeting held on October 8th. At the meeting, the Commission voted to deny the developer's appeal to the City's determination that the proposed project does not qualify for "Builder's Remedy" status under SC 85. This is not the end of the matter the developer has several avenues to appeal this decision.

The Rollingwood participants met RHE City Council members Debby Stegura and Velveth Schmitz. From RHE City Administration. Greg Grammer, City Manager; Alexa Davis, Assistant City Manager; and Jessica Slawson, Assistant to the City Manager, also participated. Deputy Derek Clotworthy, Community Relations Deputy for the Los Angeles County Sheriff's Lomita Station, chatted informally with those in attendance. The RHE County Fire Station 106 sent a large fire truck and crew to the event. Several children received guided tours of the big firefighting rig.

The City of Rolling Hills Estates and the Sheriff's Department provided informational material on various topics including Neighborhood Watch, Home Burglary Prevention, and a new LACSD Community Awareness Guide to E-Bikes.

The City Council authorized the mayor to submit a letter of support to Senate (CA) Bill 1461 (Allen), which would include landslides in state law for conditions that constitute a state of emergency by the state or local government.

Summer has passed and Halloween is over. Regular customers will see holiday decorations already at Home Depot.

We all have made it through the LACFD inspections, and hopefully all were in compliance. The weeds that popped up during the rains earlier in the year currently are all pretty much dead growth, (if they haven't already been removed) and a potential fire hazard and eye sore. State Assembly Bill 3074, (AB-3074) still is being defined by the Government and may or may not be implemented in 2025.

On that note, the City of RHE has approached a few homeowners in our neighborhood about upkeep of front yards and parkway areas. There were a few residences that had an over-abundance of weedy growth. They were contacted by the City's Compliance officer for remediation. Not only is neglect of your front yard a City code violation, it is a signal to criminals who troll the peninsula. When they see a profusion of neglected homes, it's a sign that there is lack of care and a good chance that an intrusion won't be noticed. We all know that a well-manicured neighborhood with eyes on the street is the best deterrent for crime.


The Board also has fielded a few questions pertaining to the parking of recreational vehicles on the street and in driveways. To head off any conflicts, the City's regulations regarding parking RV's is as follows:

"Recreational vehicles may be parked in a side or rear yard with a minimum 10-foot setback. However recreational vehicles may not be parked or stored in yard areas contiguous to streets or highways."

Rules for parking of oversized vehicles are explained in RHE Municipal Code of Ordinances, Chapter 17.06.440, titled: Off-street Parking Requirements (residential districts). The City's definition of an 'over-sized vehicle' as any motorized vehicle, non-motorized vehicle, trailer or combination thereof that exceeds any one of the following size dimensions, (inclusive of any projecting racks and or vehicle appurtenances): Twenty-two feet long, seven feet high or eight feet wide.

If you have your RV parked at your residence and are not sure if your RV is parked legally, you can contact the City's Code Compliance Officer at RHE City Hall [(310) 377-1577 ext. 104] for clarifications.

Southern California Edison (SCE) Planned System Upgrades

Southern California Edison (SCE) will be working on planned equipment upgrades.

pole replacements and wire hardening for fire protection in the northern part of the City, generally east of Rolling Hills Road. Most of the work will occur during the daytime hours from 8:00 am to 4:00 pm. Work along Palos Verdes Drive North will be conducted overnight, from 10:00 pm to 6:00 am, where traffic control will be implemented to maintain two-way traffic, but with delays. SCE may schedule temporary maintenance outages during construction. SCE will attempt to notify customers by phone, text, email, or mail at least 72 hours prior to outages. The project is estimated to last from October 1, 2024 to December 13, 2024.

George F. Canyon Nature Center

The George F Canyon Nature Center building is closed due to the aging condition of the facility. The canyon trail remains open, and Palos Verdes Peninsula Land Conservancy programming will continue with limited amenities.

An exciting new, state-of-the-art Nature Center building will begin construction soon. RHE will keep the community informed about the progress of the construction.

Reminder: Overnight street parking is prohibited in the City of Rolling Hills Estates.

Per RHEMC Section 10.24.090 (B)(1)

Permits allowing all night parking of vehicles may be issued dependent upon the length of time required by the applicant.

Temporary permits for up to five days can be obtained without application or investigation. Temporary permits may be renewed for additional five-day periods not more than twice consecutively or fifteen days maximum within any given calendar year.

Biking Reminders from the City:

When riding bicycles, e-bikes, scooters, etc., be safe and follow these simple tips:

- Ride in designated areas (i.e. bike lanes) and in the same direction as traffic.
- Always wear a properly fitted helmet and securely fasten the chin strap.
- Never use electronics while riding.
- Follow traffic signs and signals

Finally, the City of Rolling Hills Estates strictly prohibits riding bicycles, e-bikes, scooters, mopeds, skateboards, etc. on equestrian trails.
